If inhaled:

Immediate medical attention required. Remove the affected individual into fresh air and keep the person calm. If breathing is irregular or stopped, administer artificial respiration.

On skin contact:

## SECTION 6: Accidental Release Measures

### 6.1. Personal precautions, protective equipment and emergency procedures

Avoid breathing vapours. For non-emergency personnel: Use personal protective clothing. Ensure adequate ventilation. Keep away from sources of ignition. ## SECTION 7: Handling and Storage

### 7.1. Precautions for safe handling
